## 1 BACKGROUND

Bengalla Mining Company Pty Limited (BMC) operates the Bengalla Mine (Bengalla) located about 4 km west of Muswellbrook in the Upper Hunter of New South Wales. Bengalla operates under development consent State significant development (SSD) 5170 granted on 3 March 2015 under the *Environmental Planning and Assessment Act 1979* (NSW).

In addition to seven mining leases, BMC holds Exploration Licence No. 9431 (EL 9431). BMC lodged an Application to Undertake Assessable Prospecting Operations (APO) 15 September 2023 at the Resources Regulator (RR). The APO included in part details regarding:

- types of drill hole;
- drill hole site plan;
- duration of drilling program;
- drilling program roster and hours;
- ancillary equipment; and
- rehabilitation cost estimate.

The APO was approved by the RR 20 November 2023.

Condition 3 of EL 9431 requires BMC to carry out community consultation in relation to the planning and conduct of activities under the licence in accordance with the *Exploration Code of Practice: Community Consultation* (May 2023) (CoP).<sup>1</sup>

The CoP includes a requirement to complete an Annual Community Consultation Report which must be made publicly available within 2 calendar months of the anniversary of the grant of the prospecting title by (relevantly) publishing it online on the titleholder's website.

## 2 EXECUTIVE SUMMARY

This Annual Community Consultation Report describes BMC's community consultation in relation to EL 9431 for the reporting period of 4 July 2023 to 3 July 2024 (the Reporting Period) in accordance with the CoP.

Exploration drilling proposed (the Activity) was defined as a medium impact activity in the Bengalla EL 9431 Community Consultation Strategy (the Strategy) (BMC, 2023). Information provided during Reporting Period included:

- location and nature of the exploration program;
- commencement of exploration drilling;
- proposed Rehabilitation Objectives and Completion Criteria;
- contact details for BMC personnel; and
- details for the Bengalla Complaints and Enquiries hotline.

Information regarding the Activity during the Reporting Period was provided by:

- letter to landholders and tenants within EL 9431;
- letterbox drops to near neighbours generally within 5 km of EL 9431;
- letters sent to relevant government agencies, Muswellbrook Shire Council (MSC), NSW Department of Planning and Environment – Crown Lands (Crown Lands), and Transport for NSW (TfNSW).
- Bengalla Community Consultative Committee (CCC) meetings;
- one Community Newsletter February 2024 (published on the New Hope Group website);
- advertisement Hunter River Times 15 March 2024 regarding exploration drilling program;
- Wanaruah Local Aboriginal Land Council (WLALC); and
- NSW Government Local Member of Parliament.

The Activity commenced 9 May 2024. No significant issues of concern or complaints relating to the Activity were received during the Reporting Period other than one enquiry from a near neighbour regarding the effect of the Activity on a bore located on the enquirer property. The enquirer was assured the Activity would not impact the bore.

The Strategy was complied with (for completeness TfNSW notified 2 September 2024 due to no record found of notification to TfNSW of drilling commencement during February 2024 when other notifications occurred). No amendments to the Strategy were or are required because of community consultation during the Reporting Period. BMC intends to conduct the Activity in the next Reporting Period.

### **3 COMMUNITY CONSULTATION IN THE REPORTING PERIOD**

The Activity commenced 9 May 2024 and was ongoing. All land within EL 9431 is owned by BMC or the Bengalla Joint Venturers except for MSC roads, Crown (paper) roads and one parcel of land owned by another mining company (Hunter Valley Energy Coal Pty Limited (HVEC)). During the Reporting Period the Activity was not undertaken over Council roads or Crown roads and not on land owned by HVEC.

As required by Condition 3 of EL 9431, BMC prepared and implemented a Strategy for the Activity in accordance with the CoP. This report provides a summary of stakeholder groups identified, consultation activities undertaken and the objectives and outcomes of the community consultation.

### **3.1 Activity impact level and stakeholder identification**

The Activity was determined to be medium impact through a risk assessment which was undertaken in accordance with the methodology set out in the CoP and documented in the Strategy.

Table 3 of the CoP provides the framework for identifying relevant community stakeholders with reference to the potential impact level of the Activity. For medium impact activities, the relevant stakeholders identified were:

- relevant mine owned land, community landholders and residents/tenants generally within 5 km of EL 9431;
- MSC in respect of MSC roads within EL 9431;
- Crown Lands (in respect of Crown roads within EL 9431);
- TfNSW (for completeness TfNSW notified 2 September 2024 due to no record found of notification to TfNSW of drilling commencement during February 2024 when other notifications occurred);
- one landholder within EL 9431 being HVEC;
- two tenants within EL 9431 including the licensee of the HVEC land and Bengalla Agricultural Company Pty Ltd;
- the CCC (the CCC has been established as required by the conditions of development consent State significant development 5170 for Bengalla and its members comprise representatives from BMC, the MSC and local community); and
- the Upper Hunter community.

EL 9431 does not have a condition regarding native title (as native title has been demonstrated to be extinguished in all the land and waters within EL 9431). In that context, no consultation was necessary with native titleholders or claimants. As a courtesy WLALC was notified.

### **3.2 Consultation requirements for medium impact activities**

Where Activities have been categorised as medium impact, the CoP requires the following minimum community consultation actions:

- consultation that may include phone conversation(s), meeting(s) and written communication(s), for example, email(s), letter(s) and/or newsletter(s); and
- responses to any correspondence or submissions.

Information is provided below about the consultation activities conducted, objectives of that consultation and outcomes achieved and issues raised in respect of non-government stakeholders and government stakeholders.

## 4 CONSULTATION WITH NON-GOVERNMENT STAKEHOLDERS

### 4.1 Consultation activities

The Strategy sets out the consultation plan for stakeholders in respect of the Activity. The part of the consultation plan relevant to non-government stakeholders is extracted at Table 1. The activities undertaken by BMC in accordance with that consultation plan are summarised at Table 3.

### 4.2 Objectives of consultation with non-government stakeholders

The Strategy sets out the consultation objectives for the Activity, which are extracted below. BMC aims to maintain good relationships with government agencies, other stakeholders and the local community. BMC's community liaison objectives are:

- ensure that Bengalla consistently builds upon its credibility within the region through a process of engagement and transparency within neighboring communities;
- be proactive rather than reactive;
- build awareness and provide information on current and future plans;
- keep all stakeholders well informed;

- establish working relationships with stakeholders;
- address any concerns where appropriate, held by residents and other stakeholders; and
- minimise any potential disruptions and inconvenience to residents and operations.

### 4.3 Summary of discussions, outcomes and issues

No significant issues of concern or complaints relating to the Activity were received during the Reporting Period other than one enquiry from a near neighbour regarding the effect of the Activity on a bore located on the enquirer property. The enquirer was assured the Activity would not impact the bore.
